Resolution: - The Staff Council endorsed the proposal submitted by the Committee to frame the Rules and Regulation for payment of remuneration to the Experts, Technical and Non-Technical Staff and members of the Admission Committee.

Further, following addition to the above was also resolved unanimously:

- Further, staff council added that wherever Admission Committee member/(s) serve as Expert for evaluation of Sports Proficiency Certificate and/or Physical Fitness Test he/she will be appropriately remunerated at par with the Expert remuneration as per the Delhi University Norms.
- The Council unanimously endorsed to pursue with the DU Authority for sharing of funds received from students towards admission for payment to Experts engaging with the admission process.
- Delhi University may be requested to accord approval for charging additional fees from the candidates at college level to meet the expenditure on payment of remuneration to the members of Admission Committee and the support staff.
