At the very outset the Secretary of the Staff Council welcomed the Chairperson and members and requested to proceed with the agenda items.

The following resolutions were adopted unanimously.

Agenda 1: Confirmation of the Minuets of 150th Staff Council.

Resolution: Staff Council unanimously accepted the 150th minutes of the Staff Council held on 07.10.2022.

Agenda 2: Merit, Sports and NCC Scholarships.

Resolution: The Staff Council discussed the resolution of Fee and Scholarship Committee 2022-23 and resolved the following changes with regard to imparting fee concession:

- Since the students of II and III year of UG Course and B.P.Ed II Year and M.P.Ed. II Year are not being awarded any fee waiver from the Delhi University, therefore, it was resolved to provide the fee waiver to such students on the basis of following criteria:
 - 1. Fee Concession 2022 -23 (Appendix I)
 - a) Family Income of a student less than 02 lakhs and below will be provided full fee waiver excluding sports kit fund and development fund.
 - b) Family Income of a student above 02 lakhs and up to 05 lakh will be provided with a 50% fee waiver excluding sports kit fund and development fund.
 - c) Family Income of a student above 05 lakhs and up to 08 lakh will be provided with a 30% fee waiver excluding sports kit fund and development fund.

Note: In case of paucity of funds, equal distribution of amount among the claimants to be made in the category of Rs. 02 to 05 lakhs and 05 to 08 lakhs respectively excluding Sports Kit Fund and Development Fund.

- Resolution of Academic Scholarship was accepted and recommended to the Governing Body for acceptance and approval. (Appendix – I)
- 3. Sports Scholarship 2022-23 item no. III Award Category III under column "Certificate Issuing Authority", the word SGFI shall be deleted. (Appendix I)



Agenda 3: Teaching Assistantship for M.P.Ed. final year students.

Resolution: It was unanimously resolved by the Staff Council to provide Teaching Assistantship to the M.P.Ed. final year students with the following criteria:

- a) The first three students on Merit basis of sem III shall be considered for Assistantship.
- b) Assistantship will be provided in all 13 discipline/sports.
- c) Concerned specialization teacher may be asked to recommend the name for Teaching Assistantship.
- d) An amount of Rs. 1000/- per month shall be paid to the student as honorarium.
- e) Up to 15 working days in a month, the student will be entitled to get honorarium @ 50% i.e. Rs. 500/- only.

Mater arising out of the Minutes.

Resolution: An undertaking regarding the use of Institute's Laboratory was circulated earlier particularly for the Biomechanics Laboratory. Now, it is resolved that same undertaking shall be applicable to all the Laboratories existing in the Institute. The Head of the respective department shall forward a new undertaking to be used from time to time.
